

Declaration of Warranty

Limited Warranty

‘SAMJIN LND CO.,LTD’ warrants that the ‘LED products’, if properly used and installed, will be free from defects in material and workmanship and will substantially conform to ‘SAMJIN LND CO.,LTD’s’ publicly available specifications for a period of five years after the date the ‘LED products’ was purchased, and the lumens will be 70% or greater than the initial lumens over the 7-year warranty period (whether purchased separately or as part of a system).

If the ‘LED products’ which is the subject of this Limited Warranty fails during the warranty period for reasons covered by this Limited Warranty, ‘SAMJIN LND CO.,LTD’, at its option, will:

- 1) repair the ‘LED products’ by means of hardware and/or software; or
- 2) replace the ‘LED products’ with another ‘LED products’; or
- 3) refund the purchase price of the ‘LED products’ if ‘SAMJIN LND CO.,LTD’ is unable to repair or replace the ‘LED products’.

This Limited Warranty, and any implied warranties that may exist under the law, apply only to the original purchaser of the ‘LED products’ or ‘LED products’-based equipment and last only for as long as that purchaser continues to own the ‘LED products’.

How to Obtain Warranty Service

To obtain warranty service for your ‘LED products’, you may contact your manufacturer in accordance with its instructions or, as an alternative option, you may contact ‘SAMJIN LND CO.,LTD’.

To request warranty service, contact ‘SAMJIN LND CO.,LTD’ within the warranty period during normal business hours excluding public holidays (refer to back cover for information regarding how to contact ‘SAMJIN LND CO.,LTD’ in your particular region). Please have the following information ready in advance.

- (1) Your name, address and telephone number(s)
- (2) Proof of purchase
- (3) A description of the ‘LED products’ including the brand, model number and serial number, etc.

(4) A specific explanation of the problem

[Note: The Customer Service Representative may need additional information from you depending on the nature of the problem.]

The warranty of the replacement 'LED products' will be covered by this written warranty and is subject to the same limitations and exclusions for the remainder of the original warranty period or one year, whichever is longer.

Warranty Limitations and Exclusions

These warranties replace all other warranties, either express or implied, including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose. 'SAMJIN LND CO.,LTD' disclaims all other warranties, either express or implied, including implied warranties of merchantability and fitness for a particular purpose without limitation. Some jurisdictions do not allow the exclusion of implied warranties, therefore, this limitation may not necessarily apply to you.

All express and implied warranties are limited in duration to the Limited Warranty period. No warranties shall apply beyond that specified period. Some jurisdictions do not allow limitations on the period for which an implied warranty is valid, therefore, this limitation may not necessarily apply to you.

Limitations of Liability

'SAMJIN LND CO.,LTD's' liability under this warranty or any other warranty, either implied or express, is limited to repair, replacement or refund as per the statement stipulated above. These remedies are the sole remedies available for any breach of warranty. 'SAMJIN LND CO.,LTD' is not liable for direct, special, incidental or consequential damages resulting from any breach of warranty including, but not limited to, lost profits, downtime, goodwill, damage to or replacement of equipment and device, and any costs of recovering, reprogramming or reproducing any program or data stored in or used with certain equipment containing your 'LED products'. Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, therefore, the above limitations or exclusions may not necessarily apply to you.
